1	Item 2. 22/129 Preceptorship Principles Consultation The Council discussed the importance of precise wording in relation to the term principles, noting that if there was no statutory footing for the principles and they would not be enforced, terming them guidance may be more appropriate. The Council also suggested that a clear statement of the purpose of the principles and their use be included at the start of any published document. The Executive noted that some HCPC guidance did have a statutory footing so the potential for confusion would remain should the term guidance be used. The Executive would reflect on the language used. (2.4)	Executive Director of Governance Assurance and Planning	Amended titling was discussed with HEE, funders of this work who had concerns that the change would diverge from existing terminology used in the health sector, and the impact this could have on the extent to which the principles would be useful and integrated into practice. Due to these concerns, it was agreed with the relevant Council member and the Chair that we should retain the current titling but ensure a clear statement of purpose is included at the start of the final published document, as well as ensuring clear titling for future guidance developed.			
2	The Council noted that the HCPC's data analysis had found there was a 94% retention rate within 4 years of joiners to the register. The Council asked for the Executive to explore how this compared with non-HCPC regulated healthcare professions in order to provide greater clarity as to whether the HCPC's attrition rate was an outlier.(2.5)	Executive Director of Governance Assurance and Planning	Not all regulators carry out and publish this type of analysis and there are differences in how professionals are trained and how analysis may have been carried out. However, the GMC do analyse leaving rates within their workforce report, over a six-year period. Their most recent report shows that approximately 90% of UK medical graduates who first took up a licence to practise in 2015 remained registered four years later; a lower retention rate than for HCPC professions.
